

**Beverly Public Schools  
Kindergarten Registration

Frequently Asked Questions**

***\* What documents must I bring with me to kindergarten registration?***

Parents and/or guardians must present an **original** birth certificate (may be obtained at City or Town Hall where child was born), 2 forms of proof of residency in Beverly (this must be documentation tied to ownership/rental of property in Beverly for example; Deed, lease, real estate tax bill, mortgage statement along with a recent gas, water, sewer or electric bill); If you reside with someone else, please provide a notarized letter from the owner stating that you and your child/children reside with them at their address and then provide the 2 forms of proof of residency as listed above in their name and the following completed forms from this packet:

- Student Data Form
- Home Language Survey
- Health Questionnaire
- Kindergarten Program Preference (Full or Half day)
- Immunization / Proof of Physical Exam Record
- Scholarship Form (only if applying for financial assistance)
- \$400.00 deposit if you are NOT applying for a scholarship

***\*Your child must be 5 years of age on or before August 31, 2017. There are no exceptions to this date.***

***\*What are the medical requirements for my child to attend public kindergarten?***

The Massachusetts Department of Health requires that all children entering school must have:

- five (5) doses of DTaP
- four (4) doses of Polio Vaccine  
\*\*These two requirements are waived if the child received their fourth dose of DTaP or third dose of polio vaccine on or after their fourth birthday.
- two (2) doses of MMR
- three (3) doses of Hepatitis B
- two (2) doses of Varicella, unless the child has a physician-certified reliable history of chicken pox disease.

**No student will be permitted to attend on the 1st day of school without:**

- proof of necessary immunizations,
- proof of lead screening,
- a completed "Massachusetts School Health Record," documenting a physical examination
- (including an eye exam) completed within six (6) months before entry into school.

In the case of children with summer birthdays, please forward these completed materials before August 31, 2017 to the McKeown Building at 70 Balch Street. **Again, please keep in mind that no student will be allowed to attend on the first day of school without a complete health record.**

Free regular physical examinations, including immunizations and lead screenings, are available at the Well Baby Clinic (Lydia Pinkham Clinic), which is located at 250 Derby Street in Salem, near Pickering Wharf. The clinic hours are Tuesday and Thursday, between 1:00 and 4:00 p.m. (physicals are done on Thursdays) No appointment is necessary. If a lead screening is required a referral will be made at the time of the physical. For more information, please call (978) 744-3288.

*\*What steps does this school district take to screen incoming students to determine if they might require educational assistance?*

The Massachusetts Department of Education requires school Entry Screening in recognition of the fact that, if a child is in need of some educational assistance, the earlier that assistance is offered, the greater the benefit to the child. Screening in Beverly will take place at local elementary schools in the spring of 2017. Screening is not a test. Rather, screening briefly samples a child's functioning in areas such as receptive and expressive language, fine and gross motor skills, auditory and visual functioning, memory, an awareness of the world and the ability to follow directions. A team of educators made up of special education staff, counselors, related services providers, and classroom teachers conducts this program, followed by a team review of each child's performance. In those situations in which additional information is needed, parents are contacted and further evaluation is discussed. However, no child is refused entry to kindergarten on the basis of this screening. Screening is available for those kindergarten students who will enroll in private schools, as well as being required for admission to public school. Parents of private or parochial kindergarten children may request that the results of the screening program be shared with the school in which that child is attending.
